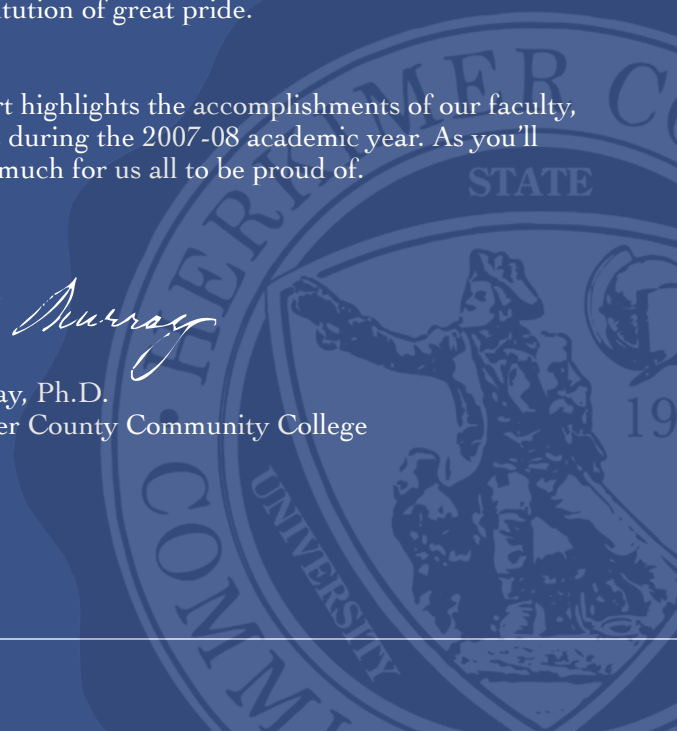

LEADERSHIP

In June 2008, Dr. Ronald F. Williams retired after 22 years of service to HCCC. Williams' accomplishments over his two-decade leadership at HCCC included many new and modified academic programs, significant enrollment growth, implementation of a successful Internet Academy, a nationally-ranked intercollegiate athletic program and several construction and renovation projects.

On August 11, 2008, the campus community welcomed Dr. Ann Marie Murray to Herkimer County Community College. Dr. Murray's appointment was the result of an eight-month national search for a new president that yielded 53 applicants.

While settling into her new role and her new home in the Village of Herkimer, President Murray began a busy schedule of interviews, meetings, receptions, luncheons and speaking engagements. "As the new leader, it is my job to find out what the College and community need," said Dr. Murray. Her short-term goals include identifying the direction in which to lead the College, which includes development of a strategic plan with benchmarks and assessment. Dr. Murray is looking to support the faculty in identifying and creating new areas of excellence in the hopes of finding future niches that will help identify the institution.

Chinese Students from Earthquake Area at HCCC

Eleven students from Sichuan Province, China, an area that suffered a massive earthquake in May arrived in Herkimer in August to attend HCCC for two semesters as part of the SUNY China 150 Program. HCCC is one of 22 campuses within the State University of New York system hosting a total of 150 students. President Ann Marie Murray and several administrators traveled to New York City in August to meet the students and escort them to Herkimer.



The College's 40th annual Commencement was held Friday, May 16 in the gymnasium. A total of 528 students graduated including 50 Internet Academy students. The class represented the United States and 11 other nations including Japan, Canada, Vietnam, Kenya, Thailand, United Kingdom, Indonesia, Korea, Venezuela, Poland and Lithuania.

EXCEL

Herkimer received the National Alliance of Two-Year College Athletic Administrators (NATYCAA) Cup award for its second place national finish among non-scholarship Division III community college athletic programs in 2007-2008. The NATYCAA Cup awards are given annually to recognize overall athletic program excellence by two-year colleges at the national level. This is the third consecutive year that Herkimer has won a NATYCAA Cup, and the first time in college history to finish second.

National and Regional Championships

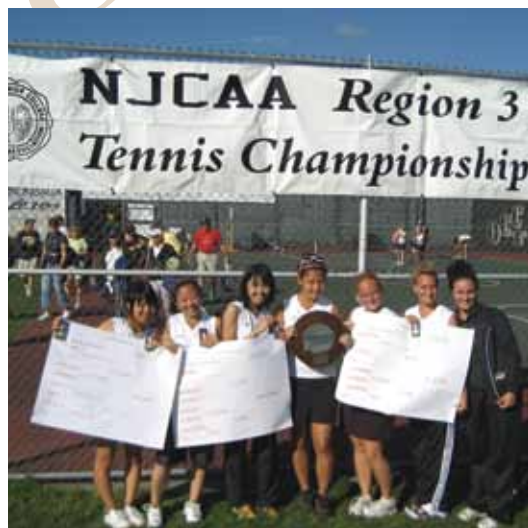
The women's track and field team captured the regional and national championships in the spring, as well as two individual national titles. Team members Chantel Salamone and Amanda Davey won the national titles for the 200 and 400 meter hurdle events, respectively.



The women's tennis team captured three individual Region III championships at top flights, qualifying them to compete at the National Junior College Athletic Association (NJCAA) national tournament in Tucson, Arizona. As a team, Herkimer finished one point behind Broome Community College in the closest regional tournament in recent years.



The swim team also won three individual regional championships and set 14 new school records at the Region III/Northeast District swim meet. The team went on to compete at the NJCAA national swimming championships at Indian River Community College in Fort Pierce, Florida.



Academic Success of Student-Athletes

The women's swimming and women's bowling teams earned the distinction of being named National Academic Teams of the Year with average GPAs of 3.79 with 3.28 respectively. NJCAA awards this honor annually to teams with an average cumulative GPA of 3.0 or better.

Three students received the SUNY Chancellor's Scholar Athlete Award, recognizing a combination of academic excellence and outstanding athletic achievement. Recipients of the 2007-08 award included 76 student athletes from 27 SUNY campuses in 25 different sports. The recipients from HCCC, all May 2008 graduates, were Ivan Guarin, men's soccer; Justin Hayes, men's lacrosse; and Denise Kelly, women's track.

Twelve student-athletes received the 2008 Academic All-Region award, an honor given by NJCAA Region III to athletes who have earned at least 45 credit hours and a grade point average of 3.5 or better. Eleven student-athletes were named Academic All-Americans with GPAs of 3.6 or higher, and five received the honor of Distinguished Academic All-Americans with 3.8 or higher. A total of 181 student-athletes have been named Academic All-Americans since 1992.

The demand for transfer counseling increased with 575 appointments during the year. Additionally, 141 students sought transfer counseling through the Wednesday Walk-Ins program, a new option for students seeking transfer assistance. The Counseling Center also saw an increase in demand of personal counseling by students, from 392 in 2006-07 to 548 in 2007-08.

CAMPUS

As a result of a renewed emphasis on non-credit programming, the College's non-credit offerings grew from 11 in the fall of 2007 to 68 in the fall of 2008, with a total of 887 non-credit enrollments during 2007-08. A part-time program specialist was hired and based at the Herkimer Working Solutions One-Stop Center resulting in assistance to 131 community members, of which 21 applied for admission at HCCC.

More than 350 outside groups utilized College facilities, including the Hummel Corporate and Professional Education Center, for events, conferences and meetings. Notable events held at the College included the Herkimer Veterans Conference, American Red Cross Great Heroes Breakfast, Crusader's Wine Tasting, Albany Adolescent Youth and the Valley Health Services Magic of Herkimer.

The College continued to identify and implement more efficient and effective ways of providing services. One such improvement was a new procedure allowing on-campus students to register for classes online, rather than in person, eliminating long lines for students. The process by which Veteran Administration certificates are processed was also changed, allowing VA students to receive their funds much sooner.



PROGRAMS AND SERVICES

The College experienced a four percent increase in applicants from the previous year, a total of 4,287 applicants for the fall and spring semesters. The number of new students that matriculated for 2007-08 was 1,361, a six percent increase from 2006-07.

Participation in **College Now**, a concurrent enrollment program for high school students, grew considerably. Morris Central School joined the program for a total of 13 participating schools. The program enrolled 423 students during the year, an increase of 16.5 percent over the previous year.

The **Internet Academy** continues to be an integral part of the College's offerings with 19 degrees and four certificate programs available completely online. The number of students taking online courses grew from 1,280 in fall 2007 to 1,312 in spring 2008, while the number of students studying entirely online decreased from 780 to 670. The fall of 2007 marked a major change in how the Internet Academy delivers courses, converting all HCCC online courses to the ANGEL Learning Management System and providing an ANGEL 'course shell' to all HCCC courses, allowing on-campus faculty to provide web-enhancements to their courses. The Internet Academy staff provided additional support for students and training sessions for faculty, including a professional development session "Internet Academy: Our New Look" and ANGEL demo sessions for new part-time and College Now instructors.

The **Cybersecurity** program was expanded so all requirements of the degree could be completed online through the College's Internet Academy. A new **Medical Coding/Transcriptionist** certificate program, offered online only, was implemented. A new associate in science

degree program in **Music Industry** was developed and approved. The program is designed to give students a strong foundation in music business. Courses cover topics such as music in theory



and performance, recording, distribution and marketing, promotion, copyright and contract law, royalties and management. The program is designed for transfer to a four-year institution for more specialized study.

There were 32 active student clubs and organizations and 157 activities planned during the year. Eighty-eight of the events were co-sponsored with other student organizations and College offices along with 24 community service projects completed, a significant increase from years past. In an effort to promote wellness, events such as Chocolate Day, Stress-Less Day, Clean Hands Day, Alcohol Awareness Fair, and National Condom Day were held, as well as the annual Wellness Day with 32 organizations represented and 220 students in attendance.

The Herkimer County Counselors' Association held its annual "**College Night**" program at HCCC. The program gave Herkimer and Oneida County high school students and their parents the opportunity to gather information and meet with admissions representatives from more than 60 colleges throughout the northeast.

In the spring, the College completed a \$6.85 million **Library Complex** construction project resulting in a state-of-the-art educational facility for students, faculty and staff, as well as for local high school students and community members. The project included the expansion and modernization of the Library, Bookstore and Academic Support Center. The cost of the project was shared equally by the State and the College, with one million dollars contributed by the Faculty-Student Association. New features include a video wall at the entrance, additional student space, new elevator for easier access, group study spaces, private testing suites, larger archive room, new furnishings and computers, a library reading room, and bright, open, inviting spaces, including an outside terrace. Additionally, the building's infrastructure was improved with new sprinkler and HVAC systems and energy efficient windows. A dedication ceremony with a naming of the Ronald F. Williams Library was held in May.

The **new bookstore** was recognized in the *College Store and Design Magazine* for its modern and open design. It was one of only four bookstores nationally to be highlighted in the publication.



The College continued to strive to be a safe place for students, employees and campus visitors, and began the process of examining and revising campus safety and security procedures and practices. Several **campus safety improvements and new campus communication tools**, many of which are preventative measures, were implemented, including new and additional surveillance cameras monitored by computer, new lap top computers in patrol cars for viewing cameras, new car cameras added to safety vehicles, additional outside lighting and blue light safety phones, an increase in gate guard hours as necessary, and implementation of the Student Nighttime Auxiliary Patrol (SNAP). Several new campus communication tools were also implemented, including a silent witness email (silentwitness@herkimer.edu), Tipps phone line, participation in NY Alert emergency notification system and electronic campus safety alerts.

The purpose of the series is to provide local business, community and government leaders with opportunities to learn about and discuss pertinent issues in the region.

The College continues to be active in supporting and promoting the **American Heart Association's Heart Run and Walk**. Employees, students and community members were encouraged to join the HCCC team for the event, a pre-registration event was held on campus, heart sales were conducted, 'Go Red for Women' pins were sold, and a 'Children's Parade of Hearts' took place to raise money for the cause.

FOUNDATION

On behalf of the College, the Herkimer County College Foundation began work to secure funding for the renovation of the science labs in Johnson Hall, originally built in 1971. A \$1.1 million commitment of matching funds from New York State was secured through the support of Senator James Seward. Congressman Michael Arcuri helped secure \$95,305 in funding through the federal government (pictured below is Arcuri with the science faculty). The Foundation is currently conducting its “Elements Campaign” to raise the remainder of the local share for the project.



Established in 1967 as a not-for-profit corporation, the Herkimer County College Foundation assists the College through the acquisition of private funds and real property. In addition to providing more than \$120,000 annually to support student scholarships, the Foundation manages more than \$14 million in assets including ownership of one of the largest community college student housing complexes in New York State. The Foundation also hosts several events and fundraisers throughout the year, including the World Cuisine Festival, Generals Open Golf Tournament and the Herkimer County Arts and Crafts Fair. The Foundation Tuition Scholarship Program provides tuition for all Herkimer County high school seniors graduating in the top 15 percent of their high school class. The Foundation plays a vital role in the enhancement of campus life, as well as assuring that the College continues its demonstrated commitment to higher education.

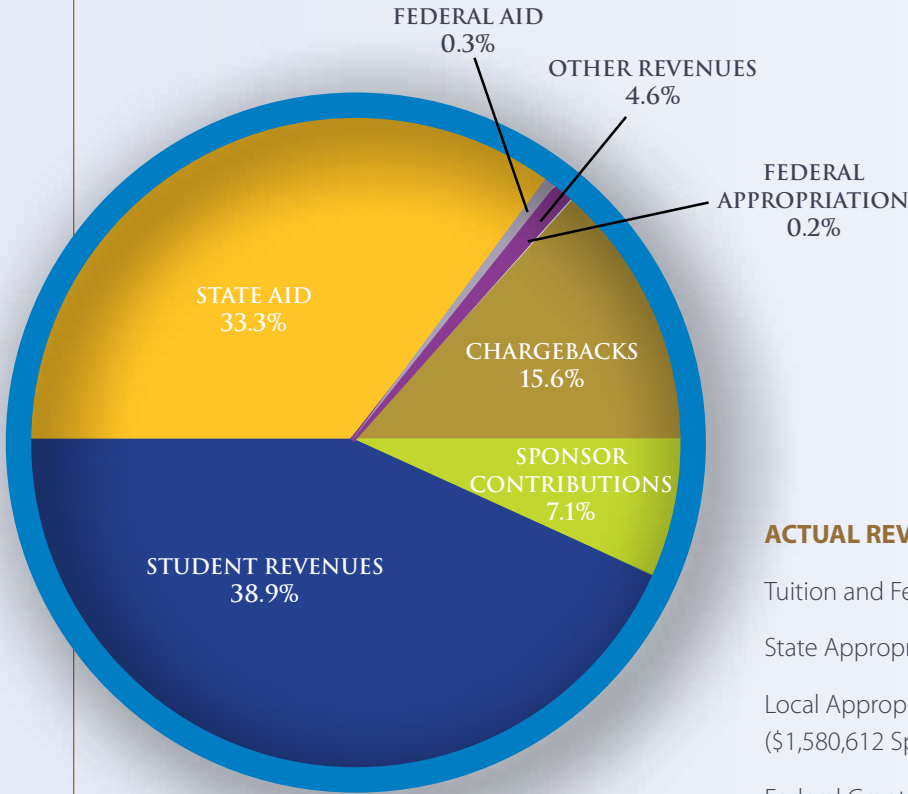

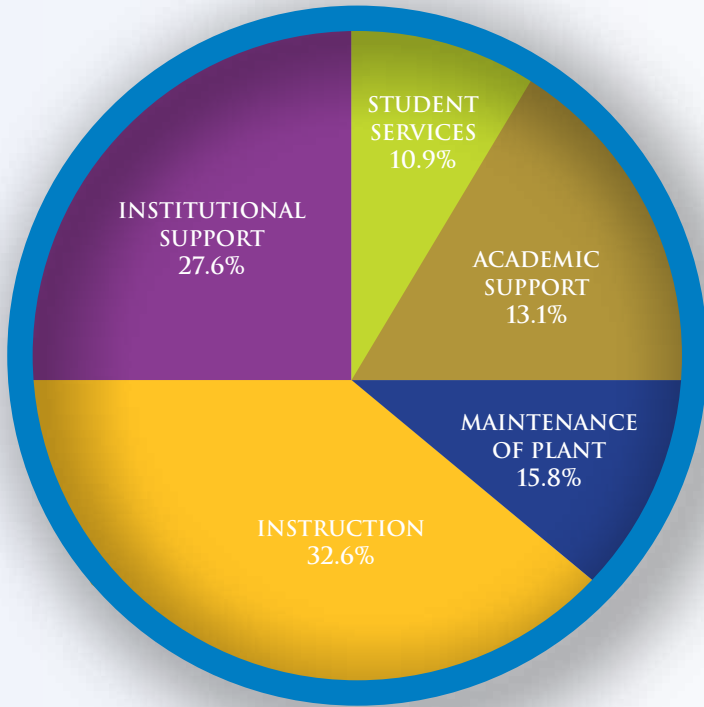

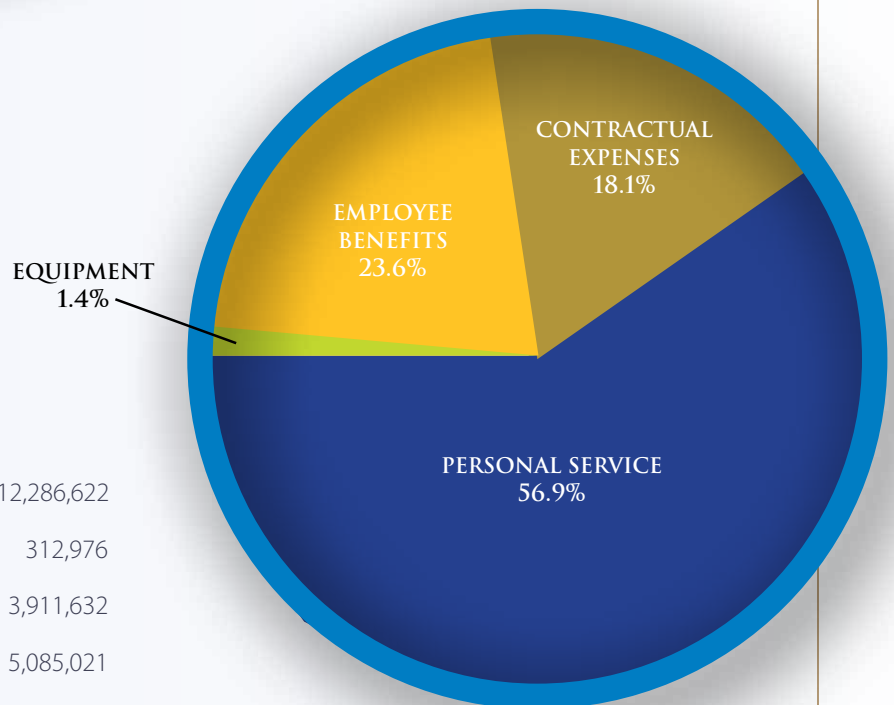
