Herkimer County Community College Hazing Policy & Procedure

Herkimer County Community College’s policy regarding hazing and the procedures used to prevent it can be found [HCCC Board Policy](#). This policy was adopted and published on July 23, 2025.

REPORTING PROCESS

HCCC encourages the reporting of incidents of hazing and takes each report seriously. It will investigate all reports diligently and thoroughly, in accordance with the [Student-Handbook-2025-2026-1.pdf](#). Any person may report an incident of hazing in person, by mail, by telephone or electronic mail, using the contact information listed for the Campus Safety Office or the Dean of Students Office.

CAMPUS HAZING TRANSPARENCY REPORT

Per the SCHA, Herkimer County Community College will compile and publish relevant and pertinent information¹ regarding each incident of hazing for which a recognized student organization was found responsible. Beginning July 1, 2025; this information will be collected and subsequently published (and updated) twice a year².
