A. Requirements:

- Student must be matriculated in a degree program at Herkimer College <u>prior</u> to the 2020 Winter Mini session.
- Student must be meeting satisfactory academic progress (SAP) requirements at the end of the Fall 2019 semester.
- Students must be registered for <u>both</u> the Winter Mini **and** Spring 2020 semesters, for at least a combined <u>6</u> credit hours.
- Students must have a valid 2019-2020 FAFSA (Free Application for Federal Student Aid) on file prior to December 20, 2019.

B. Types of Financial Aid:

- Federal Pell Grant
 - Only those students who qualify for additional Pell Grant eligibility.
- Federal Direct Loans

If a student has additional subsidized or unsubsidized loan eligibility (did not borrow the annual maximum loan amount), they will need to request the loan amount on the reverse side of this form.

- TAP
 - There is no TAP available for Winter Mini session.
- APTS

There is no APTS available for Winter Mini session.

C. Disbursements and Refunds:

• Additional financial aid eligibility will be disbursed as part of your **Spring 2020** disbursements. Disbursements will take place during the 5th and 9th weeks of the Spring term. *There will be no refunds issued during the Winter Mini session*.

D. Important Information:

- There are annual maximum amounts for both the Federal Pell Grant and Federal Direct Loans. If you are already receiving the maximum amount for Pell and Direct Loans, there will be no additional aid for the Winter Mini session.
