A. Requirements:

- Student must be matriculated in a degree program at Herkimer College <u>prior</u> to the 2021 Winter Mini session.
- Student must be meeting satisfactory academic progress (SAP) requirements at the end of the Fall 2020 semester.
- Students must be registered for <u>both</u> the Winter Mini **and** Spring 2021 semesters, for at least a combined <u>6</u> credit hours.
- Students must have a valid 2020-2021 FAFSA (Free Application for Federal Student Aid) on file prior to December 23, 2020.

B. Types of Financial Aid:

- Federal Pell Grant
 - Only those students who qualify for additional Pell Grant eligibility.
- Federal Direct Loans

If a student has additional subsidized or unsubsidized loan eligibility (did not borrow the annual maximum loan amount), they will need to request the loan amount on the reverse side of this form.

TAP

C. Disbursements and Refunds:
