**\*\*Important:** Please read the policies and procedures below to determine your financial aid eligibility for the Winter Mini session.

### A. Requirements:

- Student must be matriculated in a degree program at Herkimer College **prior** to the 2021 Winter Mini session.
- Student must be meeting satisfactory academic progress (SAP) requirements at the end of the Fall 2020 semester.
- Students must be registered for **both** the Winter Mini **and** Spring 2021 semesters, for at least a combined 6 credit hours.
- Students must have a valid 2020-2021 FAFSA (Free Application for Federal Student Aid) on file prior to December 23, 2020.

### B. Types of Financial Aid:

- *Federal Pell Grant*  
Only those students who qualify for additional Pell Grant eligibility.
- *Federal Direct Loans*  
If a student has additional subsidized or unsubsidized loan eligibility (did not borrow the annual maximum loan amount), they will need to request the loan amount on the reverse side of this form.
- *TAP*  
There is no TAP available for Winter Mini session.
- *APTS*  
There is no APTS available for Winter Mini session.

### C. Disbursements and Refunds:

- Additional financial aid eligibility will be disbursed as part of your **Spring 2021** disbursements. Disbursements will take place during the 5<sup>th</sup> and 9<sup>th</sup> weeks of the Spring term. *There will be no refunds issued during the Winter Mini session.*

### D. Important Information:

- There are annual maximum amounts for both the Federal Pell Grant and Federal Direct Loans. If you are already receiving the maximum amount for Pell and Direct Loans, there will be no additional aid for the Winter Mini session.
- If the Financial Aid Office determines a student is not making satisfactory academic progress (SAP) after the Fall 2020 semester, students will be responsible for any charges.
