	: Although the college does not evaluate academic status at the conclusion of the summer session, the Financial Aid Office DOES evaluate summer academic progress to determine future eligibility for federal financial aid. Once summer grades are posted, students that meet the dismissal criteria for academic standards will not be eligible for federal financial aid. If your current academic standing is probation or warning, you should consult with the Financial

Federal Pell Grant

Aid Office to verify eligibility.

- PELL eligible students who were part time or attended only one academic semester (fall or spring),
 may be enrolled in at least 3 summer credits to receive a summer PELL grant.
- PELL eligible students who were full time for both fall and spring semesters must be enrolled in at least 6 summer credits to receive a Pell grant for summer.

☐ Federal Direct Student Loans

Students who are enrolled in at least 6 credit hours for the summer session and who have not exhausted their annual loan eligibility may borrow a loan to pay for their summer charges. The chart below shows the maximum loans a student can borrow (subsidized and unsubsidized) for an academic year.

^{*}First year students are eligible for a maximum subsidized loan of \$3500 ** Second year students are eligible for a maximum subsidized loan of \$4500

New York State TAP

New York State Higher Education Services Corp. (HESC) offers the TAP program for eligible students attending at least 6 credit hours. They must have earned a total of 24 credit hours in the 2 previous semesters at Herkimer College (Fall 2021 and Spring 2022), assuming they meet the HESC income and academic guidelines. Students must file the 2022-2023 FAFSA and TAP application to be considered for a summer 2022 TAP award.

Note: Each full time semester of TAP eligibility earns 6 TAP points. Students may accumulate 36 points (equivalent of 6 full time semesters) at a 2 year college, but are only allowed a total of 48 points in their undergraduate career. Using TAP during the summer session for less than 12 credit hours (but must be at least 6) will earn 3 TAP points. This could potentially exhaust TAP eligibility for future terms once the maximum points are reached.

Refunds and Attendance

Students may be due a refund if their financial aid exceeds their summer charges. A student will be eligible for their refund after attendance in <u>all</u> classes has been verified and he/she has completed the minimum credit hours required for their awards. (e.g. To be eligible for a loan, a student must be taking at least 6 credit hours. If Session I class runs from 06/06/22 - 07/08/22 and Session II class runs from 06/27/22 - 07/29/22, the student will not receive a refund of excess financial aid until his/her attendance is verified in the Session II class).
