

# Senior Adult Audit Course Request

Applicants must be New York State residents aged 60 or older. Approved senior audits allow applicants to take a course without having tuition charged (some course/lab fees and/or supplies costs may apply) and with no completion of assignments required.

#### Application Procedure:

- 1. Applicant completes **Part I** of this form (below), indicating the semester, course title, and course section (CRN) they would like to audit (*see below*). The College's course catalog can be accessed at: <u>https://www.herkimer.edu/academics/course-schedule/</u>
- 2. Applicant provides her/his **Contact Information**, signs and dates this form, and submits it to the College Registrar's Office along with valid ID/proof of age.
- 3. The Registrar will notify the applicant **two days before the start of the class** if her/his request has been approved. Approval can **only** be confirmed <u>if there is space available in the class</u>.
